

# Alexandria Electoral Board Meeting Minutes

Chairman Powers called the April 12, 2023, meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Jack Powers, Bruce A. Brown, and Tom Fulton); the General Registrar (Angie Maniglia Turner); the Elections Manager (Mark Hirschman); and one member of the public (Tim Laderach).

## **Previous Minutes**

Mr. Powers moved to approve the minutes from the March 9 meeting; Mr. Fulton seconded the motion and it passed unanimously.

## **Jury Questionnaire**

From the Alexandria Circuit Court Administrator, four individuals were flagged for having declined jury duty because they were not United States Citizens and per the board's instruction they were contacted. Three individuals did not reply when contacted and their voter registration was cancelled. One individual indicated they were a US citizen. Mr. Brown made a motion to return the name of this individual back to the Alexandria Circuit Court Administrator for whatever action they determine is appropriate. Mr. Fulton seconded the motion and it passed unanimously.

## **Election Officers**

Ms. Maniglia Turner presented the Board with a list of appointed election officers who moved and are no longer eligible to serve or who requested to no longer be on the list. Mr. Brown moved to approve the deletions to the election officer appointment list; Mr. Fulton seconded the motion, and it passed unanimously.

## **Election Office Report**

Ms. Maniglia Turner updated the Electoral Board on the office's registration numbers, campaign finance reports, and budget. Also presented were options for potential polling place and precinct boundary changes.

## **Closed Session**

At 1:36 p.m. Mr. Brown made a motion to go into closed session for the purpose of discussing security and personnel matters pursuant to the Virginia Freedom of Information Act (§ 2.2-3711). Mr. Powers seconded the motion and it passed unanimously.

At 2:19 p.m. Mr. Fulton made a motion to reconvene in open session. Mr. Powers seconded the motion and it passed unanimously. Each member affirmed that to the best of their knowledge, only business matters related to security matters were discussed in closed session and no votes were taken.

## **Reappointment of General Registrar**

At 2:20 p.m. Mr. Brown made a motion to reappoint Ms. Maniglia Turner to the office of General Registrar for the City of Alexandria for a term lasting four years. Mr. Powers seconded the motion and it passed unanimously.
